This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 254 An Act Regarding Court Deposits and Revenue Reporting**

**SUMMARY**

The bill allows courts that have minimal bail account balances to maintain the deposits in less-expensive noninterest-bearing accounts. It removes the restriction that deposits must be made within 72 hours of receipt. It makes revenue reporting requirements consistent for both the Superior and District Courts.

Committee Amendment "A" adds an emergency, clarifies the language and requires bail deposits to be made in a timely manner.

**LD 257 An Act to Improve the Forfeiture Provisions of the Maine Drug Laws**

**SUMMARY**

The bill would have made the state law consistent with federal law in allowing forfeiture of property for marijuana violations, and by not requiring the state prove that every coowner of the property knew or consented to the illegal activity. It also would have required that any agency receiving property forfeited under federal procedures go through the approval and record-keeping requirements of state law. See also LD 1516.

**SUMMARY**

The bill would have removed from the law the current designations of the tier system of state court law libraries and would have allowed the State Court Library Committee to make changes in tier assignments that reflect changes in the use of the libraries.

Committee Amendment "A" (H-173) replaced the bill. It would have closed 6 of the least-used libraries and upgraded the status of two others.

**SUMMARY**

The bill would have given the Judicial Department authority to hire qualified personnel as state employees to perform court security functions in Cumberland County.
