This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 303 An Act to Extend the Right to Purchase Service Credits to State Employees Who Had Military Service in Grenada or Panama**

**SUMMARY**

This bill adds to the list of those eligible for retirement credit, those who served in Grenada and Panama during the periods of conflict in those countries. Under current law, members of the Maine State Retirement System who served in the armed forces, regardless of location, during any federally recognized period of conflict are entitled to retirement credit for this service.

**LD 370 An Act Regarding Purchase of Service Credit by Members Who Previously Taught in Other than Public Schools**

**SUMMARY**

This bill changes the method of purchase of creditable service for teachers who taught in other than public schools. Under the provisions of this bill, the teacher will pay for the nonpublic school years at the rate effective at the time of that service. Interest on the payment will be charged from the time of the nonpublic teaching service at a rate to be determined by the board of trustees of the Maine State Retirement System.

Committee Amendment "A" (S-115) replaces the bill. The amendment changes the conditions under which a member of the retirement system who taught in a parochial school or in a public or private academy may purchase service credit and adds those provisions to the laws relating to participating local districts. This amendment also adds a fiscal note.

**LD 405 An Act to Increase Allowable Earnings under the Disability Retirement Laws**

**SUMMARY**

This bill raises the amount from \$10,000 to \$15,000 that a beneficiary of disability retirement may earn before that disability benefit is reduced.
