All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

#### SUMMARY

This resolution would have called for a referendum to amend the Constitution of Maine to require that a candidate for Governor receive more than 50% of the votes cast to be elected. Currently, the candidate who receives the largest number of votes, regardless of that number's percentage of the total number of votes cast, becomes Governor. This resolution would have required a runoff election between the 2 persons who received the largest number of votes when no candidate received more than 50% of the total number of votes cast. The person who received the larger number of votes in the runoff election would have been declared Governor.

#### SUMMARY

This bill would have eased the administrative burden of processing legislative travel and expense vouchers. This bill required that, in order to receive reimbursement for authorized expenses, each Legislator must submit separate travel and expense vouchers and receipts that reflected only that Legislator's expenses.

#### SUMMARY

This bill would have established the Center for Nonprofit Development within the Division of Community Services and specified the types of services it would have provided to state nonprofit organizations in their efforts to apply and qualify for nonstate resources.
