This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 491 An Act Relating to Compensation for Hearing Loss Under the ONTP
Workers' Compensation Act

SUMMARY

This bill added the level of 3,000 cycles per second to hearing loss measurements in the workers' compensation law. It adopted federal OSHA noise standards and compensated for hearing loss based on state average weekly wage rather than the individual's wage.

SUMMARY

This bill required that a workers' compensation medical examination be done by a physician or surgeon with no prior knowledge of the case and one who has not seen the employee in connection with the case.

LD 509 An Act Concerning Illegally Employed Minors and Workers' LV/WD
Compensation

SUMMARY

LD 509 permitted minors employed in willful violation of the child labor laws to sue their employers under the common law or any statutory cause of action while continuing to receive compensation under the Workers' Compensation Act. If the minor prevailed in this action, the employer's workers' compensation liability was deducted from the civil action damages. If the employer was insured for workers' compensation liability, the employer's insurer could recover any compensation paid to the minor from the employer.

Provisions of the bill were incorporated into an omnibus child labor bill, the new draft of LD 905.

SUMMARY

This bill allowed the continuation of appeals from workers' compensation commissioner decisions to correct manifest error or injustice.
