This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**SUMMARY**

This bill would have required the installation of water saving toilets and urinals in all buildings after July 1, 1992. Prior to that date, the Commissioner of Human Resources would have been required to amend or revise the state plumbing code to conform to the water saving standards established in the bill. Water conservation measures are required for public buildings in LD 804.

**SUMMARY**

This bill proposed to suspend the operation of the Maine Yankee Atomic Power Plant in Wiscasset after July 1, 1992, until all spent fuel removed from the reactor before July 1, 1989, was no longer stored in any on-site temporary storage.

**SUMMARY**

This bill would have prohibited the driving or parking of motor vehicles on ice-covered bodies of water.

**SUMMARY**

This bill requires that the inventory and analysis required by the growth management program provisions include information on stone walls, stone impoundments and timber bridges of historical importance. The committee amendment (H-69) makes this requirement discretionary.
