SUMMARY

This bill exempts routine repair and maintenance of existing access ways to residential dwellings from the need to obtain a permit under the natural resource protection laws.

The committee amendment (H-216) expands the exemption provided in the bill to include reconstruction of existing access ways. The amendment also requires that there be evidence that the way was the prior route of access. Minimal intrusion into wetlands is allowed as long as proper drainage is installed. The exemption does not include access ways in coastal wetlands that are submerged at mean high tide. The amendment also strikes a retroactivity clause and adds an allocation section and a fiscal note.

SUMMARY

This bill was the minority report of the Commission to Study the Use of Herbicides, established by Resolves 1989, chapter 98. The bill would have moved the Board of Pesticides Control from the Department of Agriculture, Food and Rural Resources to the Department of Environmental Protection and would have prohibited the sale of produce treated with pesticides banned in Maine; increased penalties for pesticide violations; required the Department of Transportation and utilities to pay municipalities their avoided costs when entering into no-spray agreements; required research into agricultural, forestry and right-of-way alternatives to pesticides use; required ground water protection planning and established a pesticide ground water monitoring fund; amended the State's pesticide regulatory policy; changed the membership of the Board of Pesticides Control and established procedures for suspending and removing members who violate pesticide regulations; required pesticide applicators to report to the board and required the board to report biennially to the Legislature; required training and certification of pesticide users; and repealed the exemption for pesticide dealer reporting of pesticides sold in small containers.
