An Act to Amend the Laws Concerning Smoking in Restaurants

SUMMARY

This bill forbids persons to smoke in restaurants and requires restaurant operators to post no smoking signs. The penalty currently in law of a forfeiture of \$100 to \$500 is retained.

Committee Amendment "A" changes the wording of the smoking prohibition to allow both smokers and restaurant operators to be liable for a violation of the prohibition. It changes the punishment for a violation to a warning for the 1st offense and a \$50 forfeiture for subsequent offenses.
