LD 604 An Act to Redefine the Term "Committee" in the Maine Sunset Act LV/WD

SUMMARY

This bill would have redefined the term "committee" in the Maine Sunset Act to mean the joint standing committee of the Legislature having subject matter jurisdiction over any agency or independent agency subject to review. The Maine Sunset Act currently defines the term "committee" to mean the joint standing committee of the Legislature having jurisdiction over audit and program review matters. The bill also would have required the Legislative Council to transfer existing permanent full-time staff currently serving the Joint Standing Committee on Audit and Program Review to serve the joint standing committees.

LD 616 An Act to Establish a Budget Advisory Committee in Oxford County PUBLIC 204

SUMMARY

This bill established and provided the selection process for the Oxford County Budget Advisory Committee and the process of budget hearings, review and submission.

Committee Amendment "A" made a minor technical change in how vacancies are filled; added the requirement that public hearings on the budget estimate be held at times convenient for the public; and created an additional check on changes made to the budget by the county commissioners by permitting a 2/3 vote of the budget advisory committee membership to reject the change.

LD 628 An Act to Ensure Community Participation in Substance Abuse Programs and Planning PUBLIC 557

SUMMARY

This bill would have modified the language of existing law to require the State to fund the regional alcohol councils of Maine and the Maine affiliate of the National Council on Alcoholism and to base funding levels on identified needs and costs.

Committee Amendment "A" removed the requirement that the Director of the Office of Substance Abuse ensure funding to the Maine affiliate of the National Council on Alcoholism and modified the requirement to fund the regional alcohol councils by adding a provision that the councils be funded to the extent that funds are available.
