SUMMARY

This bill proposed to require any boat, other than a rental boat, powered by a motor larger than 6 horsepower to have at least one person on board who has received a certificate showing completion of a course in boating safety. Any person who operated a boat in violation of this proposed law would have been fined up to \$25. The bill would have required the Commissioner of Inland Fisheries and Wildlife to offer the boating safety course. A person holding a marine resource license issued by the Commissioner of Marine Resources would have been is exempt from this Act.
