All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

LD 796 expanded the powers of the Bureau of Employment Security to collect delinquent unemployment taxes from employers in the following ways:

- 1. It raised the penalty for filing late payroll returns;
- 2. It removed the 6-year statute of limitations for assessment of tax contributions, interest, penalties and filing fees for employers who file no return or file a false report and it tolled the statute of limitations for employers in bankruptcy;
- It authorized the bureau to pursue collection of a corporation's delinquent contributions, penalties and interest from an officer, director or shareholder of the corporation in specific instances; and
- 4. It authorized the bureau to effect a denial, suspension or revocation of licenses to conduct a profession, trade or business for failure to file reports or pay contributions, interest, penalties and filing fees.

SUMMARY

This bill required that average weekly wage for seasonal workers for workers' compensation purposes be calculated by dividing total wages, earnings, salary and unemployment for the previous year by 48.
