SUMMARY

This bill directs the Department of Human Services to seek whatever federal approval is needed to create a demonstration program, modeled after one in New York, that would provide the food stamp benefit in cash, rather than in coupons. If approval is obtained, the demonstration would be implemented and the Department would report to the Legislature by March 15, 1992 regarding the success of the demonstration.

Committee Amendment "A" (H-382) removes provisions from the original bill that require the Department of Human Services to implement the demonstration. The amendment requires only that the department seek federal approval and report to the Legislature prior to implementation. The amendment also adds a fiscal note to the bill.

SUMMARY

This bill makes reporting to the head injury registry mandatory. Reporting to the registry is currently voluntary. The bill also provides funds for the state share of Medicaid payments for case management services for persons with head injuries. Currently, these services are not available through Medicaid for persons with head injuries.

Committee Amendment "A" (H-156) replaces the original bill. It moves the registry from the Bureau of Rehabilitation to the Bureau of Health within the Department of Human Services. The amendment also adds a fiscal note.
