The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill clarifies imprecise language in the laws governing the Intensive Supervision Program. It does not substantively change the law.

Committee Amendment "A" (H-139) further clarifies language. It does not substantively change the law or the original bill.

SUMMARY

In 1989, the voters approved a bond issue for the construction of a regional juvenile detention facility in northern Maine. Construction is scheduled to begin in 1991. This bill creates in statute the Northern Maine Regional Juvenile Detention Facility, establishing the laws under which the facility must be operated.

Committee Amendment "A" (S-201) clarifies provisions of the bill relating to juveniles who may be appropriately placed in residential services provided by or through the Department of Mental Health and Mental Retardation and clarifies that the sheriff located in the county of the court which orders detention is responsible for transporting the juvenile to and from the detention facility. The amendment also removes a section on seclusion and replaces it with a similar section regarding placement of juveniles under observation, clarifying that juveniles may not be secluded from the rest of the facility without appropriate supervision and documentation, and that placement under observation may only be commenced or continued if the juvenile is a danger to self or others or is likely to attempt an escape.
