This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 900      An Act to Establish a Prospective Reimbursement System for Residential Care Facilities      LV/WD**

**SUMMARY**

This bill directs the Department of Human Services to establish a prospective payment system for boarding homes similar to the one used for nursing homes.

**LD 908      An Act to Provide Funds to Dental Clinics      PUBLIC 179**

**SUMMARY**

This bill allocates funds from the federal Maternal and Child Health Block Grant to several dental clinics in the State.

Committee Amendment "A" (S-91) replaces the original bill. It allocates the same total amount for dental clinics but deletes references to specific clinics.

**LD 912      An Act to Require State-funded Institutions and Food Programs to Provide Vegetarian Alternative Meals      LV/WD**

**SUMMARY**

This bill requires that all state-funded institutions, hospitals, homes and food programs provide as an option nutritionally balanced vegetarian meals.

**LD 921      An Act to Provide Resources for the Division for the Blind and Visually Impaired      ONTP**

**SUMMARY**

This bill provides funds to the Department of Human Services, Division for the Blind and Visually Impaired for 6 additional positions and to develop braille production capability.
