This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 947      An Act to Support an Affordable Emergency Medical Services System      ONTP**

**SUMMARY**

This bill provides funds to the Department of Human Services, Emergency Medical Services.

**LD 956      An Act to Clarify the Misbranded Food Laws      PUBLIC 230**

**SUMMARY**

This bill clarifies that notice need only be made when monosodium glutamate is directly added in undiluted form to nonpackaged food or food products offered for consumption.

Committee Amendment "A" (S-123) was reported by a majority of the committee. It clarifies the intent of the original bill, which is to require labeling only when monosodium glutamate is added to food in its crystal form. The amendment also reduces the penalty provided in present law for violating the labeling requirement. See also LD 311.

**LD 975      An Act to Provide Assistance to Mentally Ill Homeless Persons      ONTP**

**SUMMARY**

This bill provides funds to the Department of Mental Health and Mental Retardation to support homeless shelters where people with mental illness reside.

**LD 976      An Act to Increase the Fees for Marriage Licenses and Certificates of Birth, Marriage or Death      ONTP**

**SUMMARY**

This bill increases the fee for marriage licenses from \$5 to \$10 each when 2 licenses are required. It also increases the fee for a certificate of birth, marriage or death from \$5 to \$10.
