The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

The bill would have established within the Maine Municipal Bond Bank a revolving loan fund to provide assistance to water utilities that must make investments in drinking water treatment facilities as a result of the federal Safe Drinking Water Act of 1986, 42 United States Code, Sections 300f to 300j(26), as amended. This bill was nearly identical to a substantial portion of LD 887. The committee amended LD 887 to include refinements from LD 991.

SUMMARY

This bill required that temporary state positions and certain contracted personal services be eliminated prior to permanent state positions. The State would have been prohibited from using contracted personal services to replace permanent state employees who have been laid off.

Committee Amendment "A" limited the bill's restrictions to positions within departments and agencies and set conditions for exceptions. Further, the amendment required that clear and significant savings be demonstrated through the use of contract personnel for services previously provided by permanent state employment. The amendment also described overhead costs that must be included in calculations to determine potential savings and added a fiscal note to the bill.

Senate Amendment "A" removed the emergency preamble and the emergency clause.

SUMMARY

This resolve directed the Office of the Secretary of State to develop guidelines for reviewing and approving requests to use or display the State seal for commercial purposes.

Committee Amendment "A" added a fiscal note to the resolve.
