This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 1012      An Act to Require Overtime Pay for Working on Sunday in      LV/WD**  
**Certain Retail Establishments**

**SUMMARY**

This bill required that retail establishments, excluding restaurants, must pay overtime at a rate of 1 1/2 to an employee who works on Sunday regardless of the number of hours that employee works during the week.

Several bills providing for premium pay on Sundays similar to LD 1012 were considered by the committee; LD 172 was carried over.

**SUMMARY**

This bill established presumptive blood-alcohol levels of intoxication and nonintoxication for workers' compensation purposes and limited the presumption to intoxication. It allowed other evidence of intoxication or nonintoxication and prohibited intoxication as a defense for the employer if the employer knew that the employee was in the habit of being intoxicated on duty. There was a presumption that the death or injury did not result from the employee's intoxication while on duty when the injury results in the death of the employee or when the employee is physically or mentally unable to testify.

**SUMMARY**

This bill changed the definition within the employment definition section of the unemployment compensation law and brought the state law into conformity with federal law as to taxable services performed by real estate licensees.
