This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 1052      An Act to Permit the Establishment of the Workers' Compensation Apportionment Arbitration Board      ONTP**

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED

**SUMMARY**

This bill established a Workers' Compensation Apportionment Arbitration Board for disputes among insurers regarding responsibility for incapacity resulting from a combination of injuries. Decisions of the board were final and not appealable.

**LD 1059      An Act to Amend the Workers' Compensation Act to Provide for Fair Minimum Benefits      ONTP**

**SUMMARY**

This bill required that the minimum total incapacity payment for workers' compensation be no less than 50% of the state average weekly wage. It required that the minimum partial incapacity payment be based on the employee's average weekly wage of no less than 50% of the state average weekly wage.

**LD 1073      An Act to Protect Private Sector Workers against Unjust Discharge      LV/WD**

**SUMMARY**

This bill prohibited employers from terminating employees except for just cause.

**LD 1127      An Act to Increase the Probationary Period for Police Officers      PUBLIC 182**

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED
ESTY LARRIVEE CLEVELAND	OTP-AM	S-99

**SUMMARY**

This bill allowed municipalities and unions to increase the probationary period for police officers if an agreement on that issue is reached during collective bargaining.

Committee Amendment "A" (S-99) limited the extension of probationary periods over one year and allowed municipalities without unionized police forces to similarly provide for an extended probationary period.
