This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 967 An Act to Eliminate the Lobster Management Task Force****PUBLIC 607**

**SUMMARY**

This bill proposed several changes to the laws governing lobster fishing. The Class II license provision of crew assistance was proposed to be changed from 2 unlicensed crew members to one unlicensed crew member. A Class III license would have been added to permit crew assistance from 2 unlicensed crew members. Age restrictions for Class I licenses were proposed to be removed, and new license fees proposed at \$53 for Class I, \$106 for Class II and \$159 for Class III.

This bill also proposed a moratorium on the sale of licenses in 1992 and 1993 during which time only persons issued 1990 licenses would have been permitted to purchase licenses during the 2-year moratorium. A trap fee of 50¢ per trap was proposed and a trap limit program set up to reduce the number of traps that may be fished from 1,000 to 600 over a 4-year period.

The bill also proposed to establish a Commission to Study Entry into the Lobster Fishery for the purposes of reviewing the entry and exit of lobster harvesters in Maine's lobster fishery and to propose a license cap to manage the lobster fishing effort through the issuance of licenses.

Committee amendment A (S-290) replaced the bill. The amendment proposed to create a 13 member task force to study the lobster fishery.

House amendment B (H-765) replaced the Committee amendment and amended the budget bill (PL 1991, c. 591) by repealing the appropriation that would have funded the study.

**LD 1049 An Act to Establish a Lobster Management Plan****LV/WD**

**SUMMARY**

This bill proposed to establish an apprentice lobster and crab fishing license for persons who have not held a lobster and crab fishing license prior to December 31, 1991. The bill also proposed to establish a lobster management program that would have established limits on the number of traps that may be set per boat and per individual. The bill also proposed to establish a tagging system to implement the management program and to establish certain zones that would have been closed for certain specified periods each year to the setting of traps not logged with the Department of Marine Resources.
