This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 1232 An Act Regarding the Exclusivity of an Authorized Aquaculture Lease Site**

**PUBLIC 284**

**SUMMARY**

This bill creates an express penalty to strengthen the fines for unauthorized taking of cultivated marine products from an aquaculture lease site.

Committee amendment "A" (S-149) specified that the express penalty created by the bill applies only to people who knowingly and willfully engage in the unauthorized taking of cultivated marine products from an aquaculture lease site.

**LD 1233 An Act Concerning the Suspension of Licenses by the Commissioner of Marine Resources**

**SUMMARY**

This bill prohibits a person whose license is under suspension from engaging in the licensed activity as a crew member. House amendment "A" (H-422) retained the substance of the bill, but replaced the bill with language that clarified that the prohibitions included in the Maine Revised Statutes, Title 12, section 6406, subsection 1, paragraph E pertain only to persons whose marine licenses are suspended for violations that occur on or after the effective date of the bill.

**LD 1290 An Act to Restore Criminal Sanctions for Failure to Obey Lawful Orders of Harbormasters**
