This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 1279      An Act to Strengthen the Laws Relating to Junkyard Cleanups      ONTP**

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED

**SUMMARY**

This bill requires operators of automobile graveyards and junkyards to restore the premises to their natural condition within 90 days of the revocation or expiration of the permits issued for those yards. Failure to comply with this requirement is a civil violation, subject to a minimum penalty of \$100 per day and a maximum penalty of \$2500 per day.

**LD 1291      An Act Concerning Outdoor Advertising      ONTP**

**SUMMARY**

Under this bill, rotating, 4-sided signs at toll plazas and tourist information centers are permitted.

**LD 1303      An Act to Prohibit Pawn Brokers from Imposing Unfair Interest Rates      ONTP**

**SUMMARY**

This bill clarifies the meaning of a pawnbroker transaction to indicate that it includes transactions in which a good is sold with an agreement that it can be repurchased at a certain price within a certain time. It also limits interest rates charged by pawnbrokers to the same rates of interest as consumer loans.

**LD 1308      An Act to Amend the Sunday Sales Laws      ONTP**

**SUMMARY**

This bill limits the hours of operation of retail stores of more than 5,000 square feet of selling space, which were recently exempted from the Sunday sales laws, to noon to 5:00 p.m. on Sundays.
