This bill would have established a statutory basis for the adoption of the Joint Rules. Further, the bill mandated a cloture date of January 15th or later for the filing of legislators' requests for bills or resolves in the first regular session of any Legislature.

SUMMARY

This bill amended the definition of "training costs" to include overtime pay in the salary paid to officers providing police protection during the absence of an officer in training.

Committee Amendment "A" clarified that the "full cost of the salary" to be reimbursed includes fringe benefits. The amendment also added a fiscal note.

SUMMARY

This bill required the addition of economic impact statements from the State Planning Office and the Department of Economic and Community Development for proposed legislation upon the request of Legislators. It also required that agencies conduct similar analyses of the economic impacts of proposed rules.

Committee Amendment "A" required that a copy of the economic impact analysis accompany the copy of any rule sent to people requesting a copy of the rule. It also reduced the number of signatures needed to apply for a review of a rule from 100 to 25 (see LD 699). The amendment added an appropriation section and a fiscal note to the bill.
