LD 1332 An Act to Enhance Social Services and Therapeutic Patient Activities in Nursing Homes

SUMMARY

This bill establishes nursing home minimum and maximum staffing standards for social services and patient activities.

Committee Amendment "A" (S-181) eliminates the maximum standards and revises the minimum standards to conform with existing rules. The amendment clarifies that a nursing home may transfer other approved nonnursing hours to social services or patient activities if the transfer does not increase the nursing home's per diem rate.

SUMMARY

This bill authorizes the Department of Human Services to make grants to school administrative units to assist the units in providing school-based child care and allows grant money spent for this purpose to be considered an expenditure of local funds under the school funding formula.

Committee Amendment "A" (H-251) clarifies that assistance is not restricted to grants but may be made in other forms, such as chid care vouchers. The amendment also adds a fiscal note to the bill.
