#### **SUMMARY**

This bill proposed to repeal and replace the statutory provision requiring commissioners and employees of the Maine State Housing Authority to abstain from voting on issues that pose a conflict of interest.

Committee Amendment "A" replaced the bill, and added additional restrictive language to the Maine Revised Statutes, Title 30-A, section 4724, subsection 2, which prohibited employees from voluntarily obtaining interest in any project that would place them in conflict of interest during their tenure as employees of the authority.
