All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill creates the Office of Family Support within the Department of Mental Health and Mental Retardation. The office is organized within existing resources to coordinate the development and implementation of family support policy among the department's bureaus. The bill also establishes principles for the delivery of family support services and creates regional family support councils and a statewide family support council to assist the Department in setting policy and developing service plans. It also clarifies the authority of the Commissioner of Mental Health and Mental Retardation to provide family support services directly or through community agencies.

Committee Amendment "A" removes references in the bill to the Office of Family Support. The coordination envisioned by the original bill occurs without establishing a separate office. The amendment also removes a provision that would have made regional family support councils responsible for assisting the Commissioner of Mental Health and Mental Retardation to plan for the implementation of court judgments such as the Augusta Mental Health Institute decree. It also adds a fiscal note to the bill.

SUMMARY

This bill requires the Bureau of Parks and Recreation to facilitate access to public parks and wilderness areas by allowing persons with physical disabilities to access these areas over roads previously blocked off.

SUMMARY

This bill provides greater enforcement power to a state institution under the Maine Revised Statutes, Title 34-B by raising the fines for traffic offenses to be consistent with those charged by the municipality in which the state institution is located.

Committee Amendment "A" (H-333) replaces language in the bill with more common civil violation language found elsewhere in the statutes and places a maximum on the amount that may be charged for a violation.
