All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill would have standardized late fees paid by a state agency at 15% per annum on all accounts due community agencies when those accounts are 90 days or more in arrears, to further promote the purposes of the law as set forth in the Maine Revised Statutes, Title 5, section 1551.

SUMMARY

This bill would have replaced the previous statutory method of approving county budgets by transferring authority from the legislative delegation and the Legislature to a committee comprised of county citizens and municipal officials. This bill provided for a county budget process in which each county would set its own budget through a budget committee composed of municipal officers and members of the general public. The bill would have gone into effect only in those counties that approved it in a county-wide referendum held in conjunction with a regular election. The 13 counties in the State that do not have a budget committee with budget-setting authority would have held a referendum on November 6, 1992 to see whether the voters approve the creation of such a committee. Any existing budget committees within the 13 counties eligible for referendum were repealed.
