AUGUST 1991

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill would have required state employees and members of the Legislature to reimburse the State at the rate of $2 \notin$ per mile for personal use of frequent-flier awards earned on travel funded by the State.

LD 1637 An Act to Ensure Impartiality in Local Planning and Appeals ONTP Boards

SUMMARY

This bill would have prohibited licensed real estate brokers, land use developers and consultants and housing or building contractors from serving on municipal planning boards or boards of appeals.

SUMMARY

This resolution proposed a referendum to amend the Constitution to reduce the size of the House of Representatives from 151 members to 99 members and the size of the Senate from no more than 35 members to no more than 33 members. The redistricting would have been done by the 117th Legislature and the reduction in the size of the bodies would have taken effect for the 118th Legislature.

SUMMARY

This bill continued of the Kennebec County Budget Committee by repealing the sunset provision.

The Kennebec County Budget Committee was repealed on March 1, 1991. The bill repealed a section of law that was already repealed. Committee Amendment "A" reinstated a modified version of the budget committee by retroactively repealing the section that repealed the Maine Revised Statutes, Title 30-A, chapter 3, subchapter I, article 8 and adopted the following changes.
