This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**AMENDMENTS ADOPTED**

**SUMMARY**

This bill proposed to authorize the Kennebec Water District to meet the federal Safe Drinking Water Act's requirements for filtration of open water supplies by installing filter devices at the connection points for individual users. These filters would have been required to comply with federal requirements for filtration of giardia and viruses and would have been required to be monitored once a month by the Department of Human Services.

**SUMMARY**

This bill proposes to place in the hands of individual telephone subscribers the choice of whether the telephone subscriber's telephone number may be disseminated. The bill proposes to allow telephone caller identification ("caller ID") services to be used only under the following circumstances: when the consent of both parties to a telephone communication has been obtained; within private companies; in emergency circumstances; and in connection with legally sanctioned call tracing or tapping procedures.

H-388

**SUMMARY**

This bill requires cable franchise owners to file with the Secretary of State information concerning the franchise agreement, franchise owners, corporate ownership of corporations incorporated outside this State that own franchises in the State.

This bill proposed to prohibit a cable television system operator from invading a subscriber's privacy by doing any of the following without the express written consent of the cable subscriber: 1. Disseminating any information about the subscriber; 2. Disclosing the viewing habits of the subscriber; 3. Installing any equipment that allows the system operator to observe what is occurring in a subscriber's household. The committee amendment (H-388) deletes 1 and 2 and retains 3.
