This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the far right of the title. Various types of final action are abbreviated as follows:

#### SUMMARY

This bill allows residents of long-term care facilities to bring a private court action for damages and other appropriate relief if their rights as defined by state and federal law and regulations are violated by the long-term care facility.

Committee Amendment "A" (S-532) replaces the original bill. The private right of action in the original bill is maintained, but provisions for compensatory damages, lawyers fees and court costs are removed. A provision in the original bill that excluded awards from Medicaid eligibility determinations is also removed. The amendment also adds an emergency preamble, emergency clause and a fiscal note to the bill.

#### SUMMARY

This bill was carried over from the First Regular Session in order to allow time for negotiations to proceed between the Maine Health Care Finance Commission and York Hospital. The bill amends the health care finance laws to establish minimum standards for special relief for border hospitals, and would affect the revenue limits established for York Hospital.

#### **SUMMARY**

This bill was carried over from the First Regular Session. It establishes a Trauma Prevention and Control Advisory Committee and authorizes the Emergency Medical Services' Board to establish, maintain and operate a statewide trauma-incidence registry.

Committee Amendment "A" (H-915) removes provisions of the bill that create an advisory committee to oversee the trauma-incidence registry. It also clarifies that hospitals' and physicians' immunity under the trauma reporting laws is limited to actions taken in good faith in accordance with those laws. The amendment also specifies that the registry established under the trauma reporting laws must comply with the requirements of the federal Trauma Care Systems Planning and Development Act of 1990, and it adds a
