This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

Veterans' Small Business Loan Board, deletes the requirement that each member organization of the Maine Veterans' Coordinating Committee must be represented on the Maine Veterans' Small Business Loan Board and increases the required quorum to 5.

Committee Amendment "A" (H-569) added a fiscal note and language clarifying that certificates issued by FAME to evidence shares in a pool of mortgage loans are negotiable instruments. The amendment also changed the title by including the Maine State Housing Authority so that 3 changes could be made to statutes governing the authority. The first change permits the authority to finance all categories of intermediate care facilities for persons who are mentally retarded. An emergency preamble was added so that the provision may take effect upon enactment. The second change permits some members of the Indian Housing Mortgage Insurance Committee to designate staff to serve in their place on the committee. The third change makes technical corrections necessary for the transition of the energy conservation assistance programs formerly administered by the Division of Community Services to the housing authority.

House Amendment "A" (H-642) deleted Part C of the Committee Amendment that made technical corrections concerning transition of the energy conservation assistance program to the housing authority. The deleted language was redrafted and amended to L.D. 1924, "An Act Concerning the Low-income Home Energy Assistance Program."

SUMMARY

The original bill established the 1991 and 1992 allocations of the state ceiling on private activity bonds.

Committee Amendment (S-273) added a fiscal note to the bill clarifying that the allocations will not affect the general or moral obligations of the State.

AMENDMENTS ADOPTED

SUMMARY

This bill would have ensured that all general purpose support provided to regional planning commissions by state agencies be distributed equitably among all commissions. The bill would have authorized the Department of Economic and Community Development to review and approve all grants not made in support of specific projects and to require contributions to other commissions as necessary to achieve equitable funding.
