All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 1809 Resolve, to Establish the Commission to Study Secondary Vocational and Technical Education in Maine

SUMMARY

This resolve would have established the Commission to Study Secondary Vocational and Technical Education in Maine.

Committee Amendment "A" (H-570) changed the membership of the Commission, redefined the commission's duties, established a new reporting date of February 15, 1992 and added a fiscal note to the resolve.

The resolve was indefinitely postponed in the House and the Senate.

SUMMARY

The Maine Revised Statutes, Title 20-A, chapter 109 provides no guidance regarding the transfer of representative rights and assignment of teacher contracts. This bill addressed that situation. Without this bill teachers could be considered new employees in school systems with loss of seniority, sabbatical leave eligibility, continuing contract status and sick leave accumulation and could be required to pay Medicare.

This bill was designed to provide an orderly process for the assignment of teachers and to protect collective bargaining rights. The bill has been carried over to the Second Regular Session of the 115th Legislature.

SUMMARY

This bill would have required the board of directors of a school administrative district that elects to vote on annual school budgets by referendum to ensure that the form of articles proposing the school budget allowed voters to indicate whether the proposed budget was too high, too low or acceptable. If a majority of voters voting at the referendum rejected the budget as too high and time permitted, the board of directors would have had to submit an alternate budget to referendum. If there was insufficient time to submit an alternate budget to referendum or if the alternate budget was rejected at referendum, the previous year's budget would have had to be used.
