SUMMARY

This bill requires that grants or contracts by the Department of Mental Health and Mental Retardation for the purchase of mental health services for adults and children be subject to the request for proposal process. The Commissioner of Mental Health and Mental Retardation is directed to establish a schedule over the next 6 years to phase in this requirement for all contracts.

Committee Amendment "A" (H-474) clarifies that only contracts of \$150,000 per year or more are subject to the request-for-proposal process every 6 years. The amendment removes a provision from the bill that required contracts to be issued for 2-year periods. The amendment also clarifies that the request-for-proposal process is to be phased in over the next 3 even-numbered calendar years. The amendment adds a requirement that the Department of Mental Health and Mental Retardation seek consummer advice in awarding contracts. It also adds a fiscal note to the bill.

SUMMARY

This bill improves the debt collection ability of the Department of Human Services by amending existing law to clarify the mechanisms that may be used to collect or secure a debt, indicate what parties the department may collect a debt from and establish a statutory lien for debts owed the department.

Committee Amendment "A" (H-513) recognizes that several parts of the original bill were enacted earlier in this legislative session as part of Public Law 1991, chapter 9. The amendment removes from the bill those provisions already enacted and keeps those parts of the bill that add to existing law. This amendment makes technical and clarifying changes to the existing law and to the additional language. It also adds an emergency preamble, an emergency clause, an appropriation section, an allocation section and a fiscal note to the bill.
