All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill would have provided for the protection of lands of local and regional significance to the State by providing matching grants to local land trusts for acquisition and permanent protection of locally important, natural lands. This bill would have supplemented the work of the Land for Maine's Future Board, which provides for State acquisition of natural lands having statewide significance. The bill proposed to establish the Maine Local Land Trust Fund to fund the activities of the Maine Local Land Trust Board. Funds for the matching grants would have been derived from 5% of unclaimed or abandoned beverage container deposits.

LD 1826 An Act to Amend Maine's Underground Oil Storage Laws

SUMMARY

Comprehensive changes to the State's underground oil storage tank program were enacted by the 114th Legislature in 1989. This bill corrects several technical errors that were enacted as part of those changes.

The committee amendment (H-629) changes the original bill by deleting a change to the definition of "applicant" and clarifying the definition of "existing facility" by incorporating the effective date of major changes to the underground storage facility laws in the definition. An exemption for certain concrete underground oil storage tanks is added to the bill and a paragraph referring to punitive damages is amended.

This amendment also makes clear that a \$2,000,000 cap on annual fund expenditures and the deductible schedule apply to facility owners and not operators. The deductibility schedule is amended to clarify that that schedule applies to the facility owner. Language prohibiting a reimbursement for water supply loss is clarified and an exemption for emergency containment structures expanded.

This amendment also enacts a prohibition, after 1995, on the operation of an aboveground oil storage facility without underground piping that is noncorrosive. All installations of underground piping must be done in accordance with requirements for underground oil storage facilities or appropriate rules enacted by the Board of Environmental Protection.
