This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**SUMMARY**

This bill would have amended numerous terms which relate to people who are incapacitated or who have disabilities to use people first terminology. The bill also established a mechanism by which the changed terms could have been incorporated into existing law and disseminated to users of the laws.

Committee amendment "A" clarified the language that will replace several of the terms identified in the bill.

**SUMMARY**

This bill proposed to provide the Board of Trustees of the Maine State Retirement System with more autonomy in exercising its fiduciary responsibilities under the laws governing the Maine State Retirement System in matters relating to personnel employed by the system. Neither the benefits or the standing of the employees under the civil service laws and rules or collective bargaining contracts were affected. This bill was carried over to the second session of the Legislature.
