All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**SUMMARY**

This resolve authorized the Oxford County commissioners to issue bonds up to \$200,000 for improvements to the Oxford County airport. Those improvements included construction of facilities for repairing, maintaining and painting aircraft.

Committee Amendment "A" added section to the bill that limited the use of bonds to the construction and renovation of facilities at the Oxford County Regional Airport for the purpose of providing facilities to repair, maintain or paint aircraft. The amendment prohibits the county treasurer from issuing bonds until members of the Oxford County delegation certified that the bonds would be used in conjunction with grants, and that any lease agreement for the facilities guaranteed repayment of the bond principal and interest.

House Amendment "A" amended the procedure for bond issuance to require that the Oxford County legislative delegation serve in an advisory capacity.

**SUMMARY**

This bill amended the private and special law that established the Turner Ministerial and Grammar School Fund and allowed investment of the funds in a variety of investment vehicles, as long as the investments are made in accordance with the prudent person rule.
