This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**SUMMARY**

This bill provides that when a person who is in the Intensive Supervision Program is convicted of another crime while in the program, the person is removed from the program and serves the balance of the sentence in institutional confinement.

Committee Amendment "A" (S-190) clarifies the bill. It does not change the bill substantively. It also adds a fiscal note to the bill.

**SUMMARY**

This bill was reported by the Joint Select Committee on Corrections pursuant to Joint Order S.P. 75. The bill prohibits the State Purchasing Agent from removing the Department of Corrections from registries of suppliers unless the department asks to be removed from those particular registries. The bill also requires that contracts refused by work centers and rehabilitation facilities be offered to the Department of Corrections before going out to general bid.
