SUMMARY

The bill would amend the definition of the crime of prostitution to include sexual contact.

The Committee voted to carry over the bill to the Second Regular Session, but the First Regular Session adjourned before the Legislature took action on the carry over request.

SUMMARY

The bill corrects additional errors and inconsistencies. See LD 1926.

OTP-AM

Committee Amendment "A" (S-373) deletes several sections from the bill and adds new technical corrections.

Senate Amendment "A" to Committee Amendment "A" (S-383) makes miscellaneous substantive corrections.

House Amendment "A" to Committee Amendment "A" (H-699) makes corrections to the Knox County Budget Committee enabling legislation.

House Amendment "B" to Committee Amendment "A" (H-698) clarifies the definition of "insurable interest" to apply to trusts.

House Amendment "C" to Committee Amendment "A" (H-708) makes corrections in the definition of "massage therapy."

Senate Amendment "B" to Committee Amendment "A" (S-385) makes the mandatory seatbelt law applicable to operators as well as passengers in a motor vehicle.
