SUMMARY

This resolve proposed to direct the Public Utilities Commission to work with the State Planning Office, the Public Advocate and the State's electric utilities and their customers to study and analyze how electric rate minimization, as opposed to bill minimization, could become the chief factor in least cost energy planning and to report to the Joint Standing Committee on Utilities by January 20, 1992 with legislation to effectuate this result.

SUMMARY

This bill proposed to amend the law relating to "slamming". In the first session of the 115th Legislature, a bill was passed prohibiting "slamming", that is, prohibiting a local exchange carrier from changing a telephone customer's presubscribed interexchange carrier without first having received written authorization signed by the telephone subscriber from the requesting interexchange carrier. The bill proposed to amend the provision so that the authorization need only come from the requesting interexchange carrier in whatever form that carrier desired, without need of any authorization from the customer.

Under the committee amendment (S-542) the anti-"slamming" provision is simply repealed in its entirety.
