SUMMARY

This bill increases the license fee for nursing homes by \$5 per bed in order to fund a General Fund appropriation for the Long-term Care Ombudsman Program.

Committee Amendment "A" (S-614) is the majority report of the Committee. It replaces the original bill. For accounting purposes, rather than increasing the nursing home license fee by \$5, it establishes a surcharge to the licensing fee of \$5 per bed. The amendment adds an appropriation section and fiscal note to the bill.

SUMMARY

This bill appropriates funds to establish a 24-hour mobile crisis response service with respite beds that would serve persons with severe and persistent mental illnesses in Oxford County. The bill also provides funds for additional crisis workers, psychiatric support services and respite beds to serve persons with severe and persistent mental illnesses, including former Augusta Mental Health Institute patients, in Kennebec County.

The Department of Mental Health and Mental Retardation has agreed to reallocate funds within its existing FY 1993 budget to provide basic crisis services in Oxford County. The Department will submit a report to the Committee by January 15, 1993 regarding statewide implementation of crisis services.
