#### **SUMMARY**

This bill would have required a majority of people present and voting at a school administrative district budget meeting to approve the procedure of voting on the budget by secret ballot. Under current law, approval of that procedure requires the vote of only 10% of those present and voting.

#### **SUMMARY**

The original resolve requires the Department of Education to report to the joint standing committee of the Legislature having jurisdiction over education matters with recommendations, including proposed legislation, that establish criteria for identifying high-risk students and methods providing additional funding for those recommendations, beginning on July 1, 1993.

Committee Amendment "A" (H-1096) retains the requirement for the report outlined in the original resolve, but establishes the Committee for Assistance to High-risk Students to prepare and file the report. The amendment permits organizations whose members serve on the committee to provide staff support to the committee. It permits interested persons and organizations to provide outside sources of funding to finance the work of the committee and authorizes the Department of Education to administer the funds. The amendment prohibits expenditures from the General Fund and makes clear that any costs to schools or municipalities for participating in the work of the committee are not state mandates. The amendment also adds a fiscal note.

#### SUMMARY

The original bill fulfills the requirement of the Maine Revised Statutes, Title 20-A, section 15905, subsection 1, paragraph A-1, that the Commissioner of Education recommend to the Legislature a maximum debt service limit for school construction projects for the next biennium. The debt limit for 1995 was established at \$69.000,000.

Committee Amendment "A" (S-557) adds the commissioner's recommendation that \$69,000,000 also be the maximum limit for 1996 and adds a fiscal note.

Senate Amendment "A" (S-784) reduces the maximum limit for 1995 and 1996 from \$69,000,000 to \$67,000,000.
