#### SUMMARY

The original bill restores the method in effect prior to July 1, 1991 of calculating annual service credit to certain part-time, seasonal, intermittent or legislative employees.

The Committee Amendment replaces the original bill.

Section 1 permits the Maine State Retirement System to collect from the employer any additional actuarial and administrative costs that result from an employer's improper application of retirement statutes and rules, provision of misinformation or omission of information.

Section 2 requires the retirement system to permit part-time and seasonal state employees who were employed between January 1, 1989 and June 30, 1991 to accumulate one year of creditable service for each year in which the employee is employed for 1,000 or more hours. The same provisions apply to an employee whose position is in a career ladder that requires the employee to move from full-time to seasonal status when accepting a promotion.

Section 3 permits state employees or teachers who are laid off to purchase, at no cost to the State, service credit needed to be eligible to retire.

Section 4 ensures that the position of advocate at the Maine State Prison continues to be under the special retirement plan that covers employees of the Maine State Prison.

Section 5 makes the retirement incentive enacted in 1991 available for employees who retire before July 1, 1993.

Section 6 permits certain employees promoted to level II or level III educational technician positions to elect to continue coverage under the retirement system or plan under which those employees were covered before promotion.

The House Amendment includes only sections 2 and 6 from the Committee Amendment. LD 2462 enacted sections 1 and 4 from the Committee amendment.

#### **SUMMARY**

This bill authorizes the construction of 2 veterans' homes, not to exceed 120 beds. One of the homes would be located in eastern Maine and one in western Maine. The Committee Amendment locates the authorization in Title 37-B and increases the borrowing authority of the Board of Trustees of the Maine Veterans' Homes.
