### **SUMMARY**

This bill amends the Maine Revised Statutes, Title 19, chapter 10 to conform with federal law by authorizing the Department of Human Services, in accordance with rules and regulations adopted by the department and the federal Department of Health and Human Services, to pay nonrecurring expenses related to the adoption of special needs children and to expand its adoption assistance program to cover special needs children in the custody of private nonprofit adoption agencies licensed to operate in this State.

Committee Amendment "A" (S-592) replaces references to "handicapped" with "disabilities." The amendment also adds a fiscal note to the bill.

### **SUMMARY**

This bill clarifies that eating and lodging facilities that provide permanent or long-term residence require a separate category of licensure under the definition of boarding care facility. The bill also allows license dates for all forms of boarding care facilities to be staggered to permit reasonable adjustment to survey schedules.
