#### **SUMMARY**

This bill proposed to require the use of maximum contaminant levels (MCL) rather than maximum exposure guidelines if a MCL exists for a particular contaminant in any ground water remediation, evaluation, protection or monitoring project. The bill also would have required the use of specific analytical procedures to determine compliance with primary drinking water MCL standards.

#### **SUMMARY**

This bill, as replaced by committee amendment "A" (S-598), requires the Commissioner of Environmental Protection to assess existing data and data collection efforts by the State, to monitor the fate and significance of toxic substances in the freshwater, estuarine and marine environment and, if necessary, to recommend to the Legislature a state monitoring program for the collection of any additional data. The committee amendment (S-598) incorporates a series of findings that outline the characteristics of an acceptable toxics monitoring program. The Commissioner will report the results of this study with any recommendations to the Legislature in 1993.

The amendment also authorizes the Department of Inland Fisheries and Wildlife to permit other state agencies to take fish with gill nets for scientific purposes.

#### **SUMMARY**

This bill clarifies the definition of the term "subdivision" under the Maine Land Use Regulation Commission laws but does not change the intent of Public Law 1991, chapter 306.

The committee amendment (H-913) removes a requirement that the Maine Land Use Regulation Commission report to the Joint Standing Committee on Energy and Natural Resources on the number and location of 40-acre lots created within its jurisdiction and the subsequent division of those lots. It also reformats existing requirements to make them easier to read and follow. This amendment also adds a fiscal note to the bill.

A house amendment (H-960) corrects an incorrect cross-reference.
