SUMMARY

Changes in land use districts, zoning changes and resulting zoning maps are technically considered rulemaking under state law. As such, the current requirement under the Maine Administrative Procedure Act that all proposed rules must be placed in advance on an agency regulatory agenda applies to zoning petitions received by the Maine Land Use Regulation Commission, or LURC. This bill exempts LURC zoning petitions from that requirement.

SUMMARY

The stated intent of this bill was to clarify several provisions of law relating to municipal landfill closure and remediation. The provisions of law that would have been affected by this bill included: municipal closure obligations and state cost-sharing funds; the Department of Environmental Protection's authority to effect the closure of "high-risk" landfills; municipal disposal obligations; the department's regulatory authority regarding facilities that existed before modern solid waste laws; the relationship between Maine's right-to-know law and departmental closure and licensing documentation; and contaminated water standards. The bill also would have established further legislative guidance with regard to the prioritized distribution of available state cost-sharing funds; linked the availability of cost-sharing funds to municipal closure timetables; and clarified existing regulatory interpretation concerning the applicability of licensing restrictions to facilities existing before the pertinent licensing restriction laws.
