This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the far right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This resolve was one of the measures submitted by the Special Commission on Governmental Restructuring. The resolve required the Executive Department, Judicial Department and the Legislature to implement total quality management systems and required the Governor to establish an interagency task force to identify and implement cross-training programs among the natural resource agencies.

The Committee amendment (S-731) removed the interagency task force provisions of the bill.
