#### SUMMARY

This bill facilitated financing by water utilities of projects required by the federal Safe Drinking Water Act.

The Committee amendment (H-1094) replaced the bill. The expansion of the definition of "governmental unit" was eliminated and a separate definition for "water utility" was enacted. The amendment also clarified that the Maine Municipal Bond Bank may borrow money and make the proceeds available to water utilities.

#### **SUMMARY**

This bill amended the current statutes requiring the State to fund all state mandates by specifying exemptions to the funding requirement.

The Committee amendment (H-1172) clarified that state laws that affect the minimum wage are the only state wage and salary laws not considered state mandates and added a fiscal note to the bill.

#### **SUMMARY**

LD 2373

This bill established the Piscataqua River Basin Council. The duty of the council was to examine river traffic, wetlands preservation, pollution, waterfront development and other issues affecting water resources within the Piscataqua River basin and its surrounding tributaries. This bill did not take effect until similar legislation was enacted in New Hampshire.

The Committee amendment (H-1081) added a fiscal note to the bill.

The House amendment (H-1098) changed the composition of the Piscataqua River Basin Council by requiring 4 elected officials from the affected seacoast area, which includes the Town of York under this amendment.
