This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the far right of the title. Various types of final action are abbreviated as follows:

PUBLIC XXX	Chapter # of enacted Public Law
P&S XXX	Chapter # of enacted Private & Special Law
RESOLVE XXX	Chapter # of enacted Resolve
CON RES XXX	Chapter # of Constitutional Resolution passed by both Houses
EMERGENCY	Enacted law takes effect sooner than 90 days
CARRIED OVER	Bill carried over to Special Session
ONTP	Ought Not to Pass report accepted
LVWD	Leave to Withdraw report accepted
INDEF PP	Bill Indefinitely Postponed
FAILED EMERGENCY ENACTMENT	Emergency bill failed to get 2/3 vote
DIED BETWEEN BODIES	House and Senate disagree; bill died
CONF CMTE UNABLE TO AGREE	Committee of Conference formed but unable to agree
VETO SUSTAINED	Legislature filed to override Governor's Veto
UNSIGNED	Not signed by Governor within 10 days
DIED ON ADJOURNMENT	Action incomplete when session ended; bill died

LD 2447 **Resolve, for Laying of the County Taxes and Authorizing Expenditures of Somerset County for the Year 1992 (Reported Pursuant to Joint Order, HP1507)** **RESOLVE 70
EMERGENCY**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**

SUMMARY

This resolve laid the county taxes and authorized expenditures for Somerset County for the year 1992, and required that expenditures of the proceeds from drug seizures be subject to the same procedures as other county expenditures. This bill was engrossed without reference.

LD 2451 **An Act to Revise the Salaries of Certain County Officers (Reported Pursuant to Joint Order, HP1507)** **PUBLIC 852

This bill enacted the 1992 salaries of county officers. This bill was engrossed without reference.

LD 2453 **Resolve, to Transfer Certain State Lands to the Sinclair Sanitary District** **RESOLVE 75**

SUMMARY

This resolve authorized the Director of the Bureau of Public Lands to convey certain lands in T. 17 R. 4 township to the Sinclair Sanitary District.

House Amendment A (H-1314) required the Director of the Bureau of Public Lands to deposit the proceeds from the sale of this parcel in a special account until 90 days after the Legislature adjourns in 1994. The proceeds could only be used to purchase land in the Town of Sinclair before the expiration of the 90 days after legislative adjournment in 1994. After that date, the proceeds could be used to purchase any public lands.

Senate Amendment A (S-732) added a fiscal note. This bill was engrossed without reference.
