This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 10 An Act to Clarify the Enforcement Authority of the Maine Sardine Council

SUMMARY

This bill clarifies the embargo authority of the Maine Sardine Council and reinstates the substance of the Maine Revised Statutes, Title 32, former section 4155, pertaining to the council's authority to require packers to file code plans and the council's authority to enforce an embargo through the courts. The provisions of Title 32, former section 4155 that are reinstated in this bill were repealed by Public Law 1991, chapter 446, a bill that transferred the administration of the sardine grading program from the Department of Agriculture, Food and Rural Resources to the Maine Sardine Council.

The bill also makes several technical changes to ensure the consistent use of terms and definitions pertaining to the licensing of packers and the packing of sardines, kippers and steaks.

Committee amendment "A" (S-31) amended the bill by changing the penalty for persons who violate the Maine Sardine Law from a Class E crime to a civil violation with a maximum fine of \$1,000.

LD 11 An Act to Abolish the Atlantic Sea Run Salmon Commission

SUMMARY

This bill would have abolished the Atlantic Sea Run Salmon Commission and placed the powers and duties formerly held by the commission under the Department of Inland Fisheries and Wildlife. To accomplish this, the bill proposed to repeal the Maine Revised Statutes, Title 12, chapter 611, which falls under the marine resources laws, and enact similar language in the statutes governing the Department of Inland Fisheries and Wildlife. The bill would have abolished all positions at the Atlantic Sea Run Salmon Commission and transferred all its property, contracts, records and equipment to the Department of Inland Fisheries and Wildlife.

LD 13 Resolve, Directing the Commissioner of Marine Resources to Mediate a Conflict between Those Fishing for Lobster with Short Trawls and Those Using Long Trawls in the Harraseeket River

This resolve would have directed the Commissioner of Marine Resources to mediate a conflict between those who fish for lobster on the Harraseeket River using short trawls and those who fish on that river using long trawls.
