**JULY 1993**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 19**      **An Act Regarding the Holding of Juveniles in the Androscoggin County Jail**      PUBLIC 162

### **SUMMARY**

Currently, the law allows juveniles to be housed in the Androscoggin County Jail until September 30, 1993. The bill removes the deadline of September 30, 1993.

Committee Amendment "A" (S-97) sets a new deadline of December 31, 1995.

### **SUMMARY**

This bill amends the law defining the responsibility of the Department of Corrections to provide certain prevention, support and rehabilitation services to juveniles by removing language that limited that responsibility to the availability of funds.

**LD 59**      **An Act to Change the Manner in Which Debt Service on Jail Facility Bonds Is Repaid to Counties**      PUBLIC 431

### **SUMMARY**

Under current law, capital expenditures is one item included in computing the funds due the counties for the Department of Corrections for housing short-term A, B & C prisoners.

This bill eliminates the capital expenditures provision and replaces it with debt service on facility bonds. The bill also requires that revenues received by the counties be subtracted from county expenses in determining the money owed to the county.

House Amendment "A" (H-106) adds a fiscal note to the bill.

**LD 76**      **An Act Concerning Incarceration of Sex Offenders**      ONTP

### **SUMMARY**

This bill requires that a person sentenced to confinement solely for a sex-related offense be confined in an institution that houses only those with sex-offense convictions.
