JULY 1993

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

<i>DIED BETWEEN BODIES</i>	<i>House & Senate disagree; bill died</i>
<i>CONF CMTE UNABLE TO AGREE</i>	<i>Committee of Conference formed but unable to agree</i>
<i>VETO SUSTAINED</i>	<i>Legislature failed to override Governor's Veto</i>
<i>UNSIGNED</i>	<i>Not signed by Governor within 10 days</i>
<i>DIED ON ADJOURNMENT</i>	<i>Action incomplete when session ended; bill died</i>

LD 55 **An Act to Protect the Safety of Members of Municipal and Volunteer Fire Departments** **ONTP**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**
BALDACCI ONTP

SUMMARY

This bill would have authorized members of a municipal or volunteer fire department to display emergency lights and use sirens when responding to a fire. The bill also would have made the registered owner of a vehicle liable for failure to yield the right-of-way to a fire vehicle.

LD 63 **An Act Regarding the Issuance of Special License Plates** **ONTP**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**
CARROLL ONTP

SUMMARY

This bill would have created a special license plate for rescue unit workers and emergency medical services' personnel. It proposed a \$50 forfeiture for failure by inactive rescue workers to return recalled license plates to the Secretary of State.

LD 70 **An Act to Make Additional Allocations from the Highway Fund for the Expenditures of State Government for the Fiscal Year Ending June 30, 1993** **P & S 10
EMERGENCY**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**
BRANNIGAN OTP-AM S-46

SUMMARY

This bill makes supplemental allocations from the Highway Fund for the fiscal year ending June 30, 1993.

The committee amendment (S-46) replaced the bill. The amendment deallocates \$4,707,380 in fiscal year 1992-93 due to a reprojected of Highway Fund revenue.

LD 83 **An Act to Amend the Laws Governing Registration of Light Trailers** **ONTP**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**
NORTON ONTP

SUMMARY

This bill would have required registration plates for lightweight trailers to indicate the type of lightweight trailer registered.
