LD 112 **An Act to Amend the Role of the State Board of Education** ONTP

SUMMARY

The State Board of Education plays advisory, policy-making or regulatory roles in such areas as school construction, teacher certification, school approval, interstate school district formation and approval of formation of school administrative districts. This bill would have limited the functions of the State Board of Education to advising the Commissioner of Education and acting as the state agency responsible for administering federal vocational education funds.

LD 809 **An Act Relating to Conferring of Degrees by the Research Institute for Semiological Mathematics** ONTP

SUMMARY

This bill would have granted authority to the Research Institute for Semiological Mathematics to confer the degree of Doctor of Philosophy in Semiological Mathematics.

LD 897 **An Act to Amend the School Finance Act of 1985** ONTP

SUMMARY

This bill would have:

1. Remedied the inequitable allocation of the state subsidy for all school administrative units during fiscal years 1990-91, 1991-92 and 1992-93;
2. Prevented straight percentage reductions in general purpose aid or any other reduction method other than as provided by the School Finance Act of 1985; and
3. Required that Maine comply with the wealth neutrality test of the federal Impact Aid Act, 20 United States Code, Section 236 et seq. so that the State continues to receive federal aid to which it is entitled under the federal Impact Aid Act.
